

**Analysis of McCausland Genealogical Histories**  
**as contained in**  
**Burke's Landed Gentry of Ireland**

There are various editions of Burke's Landed Gentry of Ireland which include genealogies of McCauslands and related families. Not all of these genealogies are consistent. In some cases later genealogies include further information to bring the genealogies "up-to-date". In other cases they include older histories which were apparently not known to the previous researchers. Still, in other cases, information is changed - not always correctly!

It should be noted that many professional genealogists do not consider the Burke's information to be very reliable, for various reasons. First, these genealogies are sponsored by descendants who wish to go on record as descended from prominent families. In an effort to show this, they sometimes took liberties with the truth. Secondly, Burke's contains few source references, so it is virtually impossible to verify all that is published as the truth. Thirdly, the persons providing the information are not generally professional genealogists, so innocent incorrect inferences or connections may be made.

Given the possible unreliable nature of Burke's, the genealogies do provide a good starting point for research as a means for verification of the truth and filling in the blanks. So far as the McCauslands are concerned, Burke's relates nearly exclusively to the Limavady, Co. Derry branch descended from Col. Robert McCausland. As the information was provided by direct descendants, the more recent information (ca. 1800, onwards) is probably fairly reliable. Nevertheless, I have found errors relating to information provided for Lt. Gen John Kennedy McCausland and have noted them. It is quite possible that other errors also exist, particularly for branches not closely related to those providing the information to Burke's.

It is unfortunate that other McCausland genealogies present information taken from Burke's as fact without attributing the source or providing a caution. When this is done through a series of genealogies, suppositions finally are presented as hard facts. I must admit that I have used the Burke's genealogies as a primary basis for my own research and published gedcom, but would hope that eventually all "facts" presented could be further established through other sources.

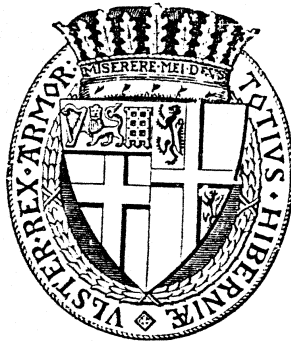
To this time, I have collected the McCausland and related genealogies from the 1899, 1958, and 1979 editions of Burke's. 'Someday' I will restructure these to make them clearer to read by incorporating the principal line into the proper places (rather than using the Burke's "of whom presently" form), making reference numbers more consistent, and reformatting to make the whole easier to follow. None of the genealogical data has been changed, even when it is known to be incorrect. When it is incorrect, I have added a note explaining why. I have also added a "<" after the name of individuals having no descendants.

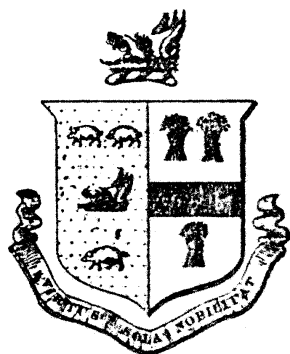

**Lineage.**—This is a junior branch (which emigrated to Ireland *temp.* JAMES VI.) of the ancient Scottish House of MacAuslane, of Buchanan, which sprang from John MacAuslane (or the son of Auslane), who acquired the lands of Buchanan, on the Lennox, and from whom they descended in direct male succession to Sir Walter MacAuslane, 11th Laird, who lived *temp.* ROBERT II., and whose grandson, Sir Alexander, was the last of the senior branch of the MacAuslanes of Buchanan. The heir male is stated to have migrated to Ireland *temp.* JAMES VI. He had two sons, of whom the elder, Andrew, was grandfather of

[At this p  the genealogy separates to three primary descendant male branches of Col. Robert McCausland - **Conolly**, **Marcus** and **Frederick**. The daughters, Sarah, Rebecca and Hannah are presented without further genealogy. These three male descendants of Col. Robert McCausland are associated with three distinct locations in the Limavady region: Conolly with **Fruit Hill**, Marcus with **Daisy Hill**, and Frederick with **Streeve Hill**. As Col. Robert McCausland was "of Fruit Hill", his eldest son, Conolly, apparently inherited this property. *Fruit Hill* was changed to the current *Drenagh* in the late 1800's and descendants still live there today. Conolly McCausland built a house at Streeve Hill in 1730 which still stands today as a hotel/B&B. There is some indication that Col. Robert McCausland had other sons not mentioned in this genealogy, as there appear to be many other lines that tradition says are descended from him.

This genealogy was prepared through the efforts of a descendant of Conolly McCausland who was still residing in Drenagh in 1979. As a member of the Ulster Defense Regiment, he was tragically killed by the IRA. His family continues to reside in Drenagh.]

Down, in trust to pay said yearly sum to my wife, and raise the sum of £18,000, for the portions of my younger children, to be divided among them share and share alike on reaching the age of 21 or on marriage, provided they marry with their mother's consent, or my exors., and that interest at four per cent be raised to provide for their education and maintenance. Should any die their share to be divided among the survivors, the trust to last one hundred years. All my said real estate to my eldest son and £500 to my wife.

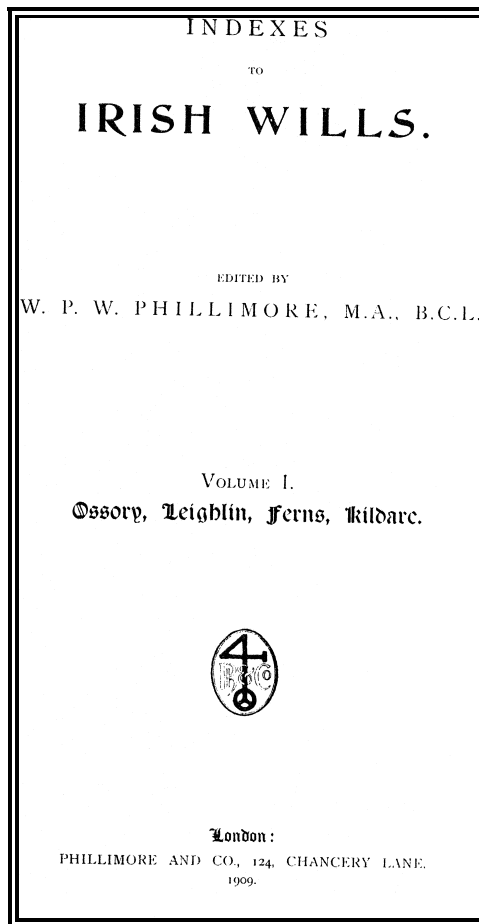

In Sept. 1914, after the outbreak of war; was gazetted 2nd Lieut. Border Regt. 17 Dec. following; served with the Mediterranean Expeditionary Force at Gallipoli from July, and was killed in action at Suvla Bay 9 Aug. 1915, while leading his platoon in the advance after the taking of Chocolate Hill. ### *The Surnames of Scotland:*

Between 1208-14 as Absalon or Absalone, 'clericus meus', he witnessed the gift by Alewin, second earl of Lennox of the church of Kamsi (Campsie) to God and S. Kentigern, and also witnessed the gift of the church of Cadinros or Cardinros (now Cardross) by Maldouen, son and heir of Alwin, to the same (REG., p. 87, 88, 93). As dominus Absalone de Buchkanan he witnessed Earl Maldouen's charter to Sir Robert Herthford, precentor of Glasgow, before 1224 (RMP., p. 217). Absalone, 'senescallus meus' or 'clericus meus', probably son of Absalon son of Macbed, appears several times as a charter witness between 1238 and c. 1240 (*Levenax*, p. 13, 91, 96, 98). Absalone, son of Absalone, probably the third of the name, along with his brothers Gilbert and Mathew, appear as witnesses between 1273 and 1315 (*ibid.*, p. 15, 16, 20, 85, 99), and Gilbert filius Absalon served on an inquisition in Dumbartonshire, 1271 (RMP., p. 191). Malcolm Macabsalon witnessed a confirmation charter by Robert I to Sir John Colquhoun, 1308 (*Lennox*, II, p. 407), and "Anslan Macgilespie de Lany" (c. 1330) is mentioned in an old genealogical tree of the Lanys of that Ilk compiled probably before 1540 (*Strathendrick*, p. 292) It may have been a Macauslan who killed the duke of Clarence, brother of Henry V of England, at the battle of Beaugé in 1421, as the duke's circle of gold was brought into camp by Alexander Macausland (*Book of Pluscardyn*). Patrick McCaslane of Caldanacht and Donald McCaslane his brother were followers of the earl of Argyll in 1536 (RSS., II, 2152), and the death of Katherine N'Chastyllan at Slattyck in Glenlyon is recorded in 1542 (*Chr. Fort.*, p. 121). John McAslan in Auchingech and Patrik More McCaslen in Auchingyle, were fined for aiding outlawed Clan Gregor, 1613 (RPC., XIV, p. 644). The McCauslands of Drenagh, county Londonderry, are descended from the Macauslans of Dumbartonshire. Makaslane 1478.
